SUMMARY

To accept the Monthly Statement's of Financial Activity for the period of 1st July 2010 to 30th June 2011.

BACKGROUND

Preparation and presentation to Council of monthly reports are a statutory requirement, with these to be presented to the next ordinary meeting following the close of a month, or it may be presented to the ordinary meeting in the following month after that.

The reporting requirements, as per Financial Management Regulation 34, for the Statement of Financial Activity came into force from 1st July 2005.

COMMENTS

The attached Statement of Financial Activity for the period 1 July 2010 to 30 June 2011 shows that the projected opening balance used for the 2011/2012 Budget will be extremely close to the final figure to be disclosed in the Annual Financial report for the 2010/2011 financial year.

Much work continues with respect to non cash end of year adjustments for preparation of the Annual Financial Statements; however these entries will not have any impact on the 2011/2012 opening balance position.

The Statements of Financial Activity for the period 1st July 2010 to 30th June 2011 show a solid position with 96.60% of rates collected to 30th June 2011 and a total amount of cash holdings of \$2,601,525 of which \$1,950,693 is held in fully cash backed Reserves.

Financial Management Regulation 34 sets out the basic information which must now be included in the monthly reports to Council.
