#### **COUNCIL BRIEFS**

#### Governance, and the Lessons to be Learned from the Inquiry into the City of Perth

Local Governments were created by Legislation and operate under a distinct separation of powers being the Council, and the Administration. The roles, functions and responsibilities of each are separate, yet complimentary. This has not always been the case.

Originally operating under the Municipal Corporations Act 1906, there was no separation of powers and "Councils" were vested with vast powers which enabled them to appoint and remove officers as and when they saw fit to do so. In the 1960's the *Local Government Act 1960* came into effect. The Chief Elective Executive Office of the Council became known as the Mayor (in the case of a city or town) and President (in the case of a shire). The Non-Elective Executive Office of a Council became known as the Town Clerk (in the case of a city or town) and the Shire Clerk (in the case of a shire).

During the 1980's a report by the advisory Council for intergovernmental relations: suggested the separation between the elected members and the executive, stating "...the primary responsibilities of the Council ... are in policy making and evaluation. Council staff should be primarily responsible for administration and the provision of advice to the elected representatives... ", and ultimately leading to the introduction of the current legislation know as Local Government Act 1995.

It was believed that the new Act would provide clarity between the legislative/policy making responsibilities of Councillors as being distinct from administrative functions and was noted in a 1995 Hansard Report that "the lack of role clarity has led to some mayors/presidents and councillors becoming involved in administrative matters which should be handled by staff. The new Act will provide a clear distinction between the representative and policy making role of the elected councillors and the administrative and advisory role of the chief executive office and other staff."

On 24 April 2018 the Minister for Local Government announced the "Inquiry into the City of Perth". On 30 June 2020, Commissioner Tony Power closed the largest and most complex inquiry into local government in the history of Western Australia. The Inquiry into the City of Perth uncovered a large number of governance failures which were widespread and entrenched throughout both the Council and the Administration. The hearings took place over 125 days resulting in 250 findings and 341 recommendations, contained within a report to the Minister for Local Government David Templeman.

Various commentary has outlined some of the findings as follows:

- > Electoral interference
- > Council made poor decisions, not proper consideration, did not consider on merits, lacked transparency and accountability
- > Did not understand or stick to what they were doing lost sight of their role
- > Failure to properly disclose interests and gifts
- > Councillors interfered in operational matters, where they had no business
- > All council members and employees bound by City's code of conduct, but improper and unethical behaviour occurred, well short of expectations
- > Service to community should have come before self-entitlement

- > Senior management was dysfunctional and inefficient
- > Did not provide good or effective leadership
- > Administration made and were allowed to make, too many poor decisions
- > Poor decisions regarding procurement of goods and services, project management, human resources and sponsorships
- > Poor governance practices
- > Widespread cultural and systemic failures
- > Failed to identify, prevent, investigate, report and act on misconduct
- > Failure to implement and enforce good government practices
- > Failure to plan for the City's future and adequately manage its finances
- > Poorly managed relationships, factionalism corrupting processes
- > Too much importance given to statutory requirements, too little to planning and financial management for the benefit of the city and community
- > Vast majority of employees did jobs well with best intentions, but leadership infected with animosity and division

In July 2017, the State Government announced a review of the *Local Government act 1995* would commence. The intent of the review is to modernise the Act and empower local governments to, "better deliver for the *community*".

On 27 June 2019, the Local Government Legislation Amendment Act 2019 was passed by Parliament and further amendments are continually progressing with key areas of change being:

- Introduction of universal training for candidates and council members;
- Greater access to information held by a local government;
- Changes to the Standards Panel; and
- The new gifts framework.
- Changes to public notice requirements;
- Changes to the authorisation of persons; and
- Other administrative matters, providing for further transparency.

Reforms expected by the end of 2020 are:

- A new code of conduct; and
- Best practice standards for CEO recruitment, performance review and early termination.

#### So what does all of this mean?

Generally speaking, governance is about the decision-making process and ensuring that there are necessary and appropriate checks and balances in place. It is about legitimate, accountable and effective ways of obtaining and using public power and resources. As demonstrated by the Inquiry into the City of Perth, anything less, including the misuse of position and power, is simply not good governance.

Modern governance requires a clear definition of the roles and responsibilities between those who govern the organisation, and those who manage the organisation. The council governs, but it must act through its officers. Each arm is necessary however, required to work independently of the others to keep them accountable.

Street and park trees improve the live ability of urban environments providing many benefits for people and wildlife

- social
- environmental
- economic

Key among these is their contribution to the amenity of parks, Public Open Space, walkability of local neighbourhoods and beautification of street verges through -

- the provision of shade to protect residents, walkers and cyclists.
- increasing community interaction as in parks, conversing with neighbours under shade
- the mitigation of urban heat island effect by shading, which modulates temperatures and increases humidity
- Deflection of wind and reduction in wind tunnel effects
- Increasing the urban forest and canopy coverage
   This contributes to enhanced community well-being and property values.
   Trees filter out air-borne pollutants and absorb atmospheric carbon, increasing air quality.
   Supporting urban biodiversity, trees provide –
- food,
- habitat
- landscape connectivity and corridors for urban fauna.

  Reducing erosion through root binding and improving environmental water quality, trees increase local infiltration following down their root systems which in turn recharges the ground water.

The social, environmental and economic benefits of trees overlap in innumerable and complex ways, making them invaluable to our urban area.

#### **Lotterywest Funded Playground and Shade Structures for Kojonup**

It is with great excitement that we can announce our success in receiving Lotterywest grant funding to provide Kojonup with a new playground and shade facility at the Sports Complex and Swimming Pool.



The Playground will be situated between the upper and lower ovals at the Sports Complex, adjacent to the ramp and Hockey club rooms. It will include play spaces for all ages, as well as outdoor gym equipment. The initial design work was done with input from community groups, and the detailed designs will be workshopped shortly.

The shade facility will be installed on the western side of the toddler pool at the Kevin O'Halloran Memorial Swimming Pool, allowing all day shade for carers and toddlers using that space. It will encourage our swimming pool users to remain close to their young ones while ensuring they are protected from the sun, especially during the afternoons.

Extensive work has gone into the planning and application process for this grant funding to be successful, and we look forward to sharing the new facilities with the community in 2021.



#### **RATES 2020/2021**

The State Government in response to the Covid-19 pandemic recommended to all Local Governments, a rate freeze for 2020/2021 to lessen the impact on household budgets. The Shire of Kojonup is heeding this recommendation and there will be no council imposed rating increase for 2020/2021.

However, the Valuer General has provided a valuation update for the Unimproved Values (UV's or Rural rates). This has resulted in an average overall increase of 7.06%, with some properties in the South West corner of the shire with increases up to 20%.

To minimise the effect this increase would have, the rate in the dollar is reduced for UV's to ensure that the same amount will be raised as the previous year. However, the larger increase in some valuations will unfortunately result in an increased rate levied than last year on those properties.

The Gross Rental Value (GRV) and the Emergency Services Levy (ESL) charges remain the same as 2019/2020. If you would like further information please contact the shire on 98312400 or council@kojonup.wa.gov.au

#### **KOJONUP REGIONAL AIRPORT UPGRADES**



The Convergence Engineering Illuminated wind indicator recently installed at the airstrip is designed and Manufactured in Western Australia to meet the harshest Australian conditions.

The design is structurally certified to withstand Region C Cyclonic conditions and the unit is constructed using high quality Australian hot dip galvanised steel to minimise corrosion.

The pivoting frame that carries the windsock uses fully sealed bearings that are protected from the weather and don't require maintenance.

The mid hinged counterweighted design allows the easy lowering of the head frame by a single person located on the ground making it simple to replace the windsock as there is no requirement to use an elevated work platform or ladders.

The lighting system consists of 4 light fittings each with dual high quality Bridgelux LEDs and fitted with custom designed lens systems to ensure compliance with the requirements of the CASA Manual of Standards for Illuminated Wind

Indicators. The lighting system has been tested and certified as compliant with the relevant CASA standards by a NATA certified testing laboratory.
