#### **COUNCIL BRIEFS**

The Council meeting was held on 28 July with 24 items on the Agenda. Council received minutes from Committees and also adopted the 2020/2021 Budget. #### **10.2** Natural Resource Management Committee Recommendations and Minutes

Council received the minutes of the Natural Resource Management Meeting held 4 June and also adopted the recommendation to approve the use of RABBAIT<sup>®</sup> Pindone Oat Bait by Mr Pritchard as a trial at the Old Railway Station Building however, conditions do apply.

#### **10.3** Sporting Facilities Major Upgrade – Funding Source

Funding and upgrade components were agreed as follows:

#### "That:

- 1. Funding through the Community Sport and Recreation Facilities Fund be retained and allocated as per the original Grant Agreement from the Department of Local Government, Sport and Cultural Industries;
- 2. Funding through the Drought Communities Funding Programme Extensions be retained and allocated with \$150,000 towards the Netball Court Roof structure; and
- 3. The 2020/2021 budget include the provision for a new loan for the purpose of providing the balance of funds required to complete the Netball Court Surface reconstruction, the Netball Court Roof construction, the Football Oval Lighting and the Sports Complex Playground and Outdoor Gym."

#### 10.4 Kojonup Child Care Centre - Memorandum of Understanding

The Shire of Kojonup and the Kojonup Child Care Centre have now entered into a Memorandum of Understanding.

#### 11.1 Electric Vehicle Charging Station

It was agreed to install an Electric Vehicle Charging Station in the two northern spaces of the Transwa Bus car park at the Kodja Place as follows:

- 1. The offer of a donated Tritium 50kW Veefill station from Synergy including installation of the unit, to a total value of \$30,000, be accepted;
- 2. The Service Level Agreement and quote for Annual Fees from Gemtek be accepted;
- 3. Use of the charging station for electric vehicles be free for the 2020/2021 financial year as a trial and a tool to promote Kojonup, following which pricing will be set at a commercial level."

#### 11.3 Proposed Repeal Local Law 2020 (Fencing)

"That a Repeal Local Law 2020, as attached and having the following purpose and effect, be endorsed for proposal and advertised for public comment in accordance with s. 3.12 (3) of the Local Government Act 1995:



- Purpose: to repeal outdated legislation (being the Shire of Kojonup's Fencing By-law gazetted on 23 December 1971 and its subsequent amendments gazetted on 31 August 1990 and 20 March 1992) identified during the Shire of Kojonup's review of its local laws.
- Effect: the repeal of the Shire of Kojonup's obsolete Fencing By-law gazetted on 23 December 1971 and its subsequent amendments gazetted on 31 August 1990 and 20 March 1992

prior to it being brought back to Council for consideration of submissions or amendments, if any, and subsequent adoption."

#### **11.5** Housing Assistance– George Church Community Medical Centre Inc.

*"That Council receives the Chief Executive Officers report and advise the George Church Community Medical Centre Inc., that:* 

- 1. The request for a cash contribution of \$250,000 or any amount for Housing is not supported as the Shire of Kojonup's intent and that of the late Mr George Church has always been the construction of a new Medical Centre;
- 2. Council does have vacant land available as per the attached plan which it would consider transferring one lot to the George Church Community Medical Centre Inc. for \$1, however the issue is what type of dwelling, unit or lifestyle property will be negotiated with prospective tenants, noting that this is a matter specifically for the George Church Community Medical Centre Inc., to progress 'Commercial in Confidence' via the Expression of Interest process the Committee is undertaking not the Shire of Kojonup; and
- 3. If the lots referred in point 2. above are unsuitable, Council is willing to explore with the George Church Community Medical Centre Inc., other lots on Shire of Kojonup owned land that may become available as part of future residential subdivision."

#### 11.6 Community Emergency Services Manager

Council chose to amend the officer's recommendation and the outcome is listed below.

"That Council:

- 1. Notes the concerns raised by the Kojonup Bushfire Association and apologises for the lack of communication regarding the DFES funding and appointment of a Community Emergency Services Manager for the Shires of Cranbrook, Gnowangerup and Kojonup;
- 2. Re-affirms the CEO's appointment of the CESM as the position directly reports to the CEO;
- 3. Notes the CBFCO and Zulu's can liaise directly with the CEO should CESM assistance be required on the fire ground;
- 4. Invite the DFES Commissioner to attend a meeting of the Kojonup Volunteer Bush Fire Association to address concerns regarding DFES relationship with Volunteer Brigades;
- 5. The position description of the CESM be tabled at the next Bushfire Advisory Committee meeting to clearly identify the roles and functions required by the CEO and allay concerns raised by the Volunteer Bushfire Association; and
- 6. The Key Performance Indicators of the CESM be reviewed after 12 months."

#### 12.3 Financial Management - Natural Resource Management Funding Arrangements

Funding for Natural Resource Management continues after Council adopted the officer's recommendation which is repeated below.



*"That Council Policy 2.1.8 (Financial Governance) be amended by adding the following immediately before the heading "Borrowing":* 

 "Natural Resource Management – In lieu of offering a discount on the early payment of property rates, 1.4% of total rates raised each year will be transferred to the Natural Resource Management reserve account for the achievement of the purpose that this reserve is established."

#### 12.5 Budget Adoption – 2020/2021 Property Rates

If you are unsure of your rates payment options, they are repeated below after being adopted by Council.

#### "That:

- 1. The following rate levels be adopted for the 2020/2021 financial year:
  - a) For all rateable properties where Gross Rental Valuations are applied a rate of 12.6476 cents in the dollar with a Minimum Rate of \$720 is to apply.
  - **b)** For all rateable properties where Unimproved Valuations are applied, a rate of 0.8410 cents in the dollar with a Minimum Rate of \$720 is to apply.
  - 2. Where payments are received after the due date, penalty interest at a rate of eight percent (8%) per annum, to be calculated on a daily basis will be imposed on all outstanding rates and service charges. Pensioners who are registered in accordance with the Rates Rebates and Deferments Act 1993 are to be exempt from this provision.
  - 3. The following rate instalment payment options be offered:

Option 1 Payment in full Total amount of rates and charges included on the rate notice to be paid in full by 3 September 2020.

Option 2Payments to be made by two (2) instalments as detailed on the ratesnotice, with the following dates:First Instalment3 September 2020Second Instalment8 January 2021

Option 3Payments to be made by four (4) instalments, as detailed on the ratenotice, with the following dates:First Instalment3 September 2020Second Instalment4 November 2020Third Instalment8 January 2021Fourth Instalment12 March 2021

4. Where payments are made by instalment, an administration charge of \$9 for each instalment after the first instalment shall apply. Interest on instalments shall be 5.5% p.a. calculated daily from the date the first installment is due until the date each subsequent installment is due, in accordance with the Local Government Act 1995. In accordance with clause 13 of the Local Government (COVID-19 Response) Ministerial Order 2020 this administration charge and instalment interest cannot be applied to an excluded person that has been determined as suffering financial hardship as a consequence of the COVID-19 pandemic in accordance with Council Policy 2.1.12, Financial Hardship.



5. Given the charitable nature of The George Church Community Medical Centre, the 2019/2020 property rates for Lot 3 Spring Street, Kojonup of \$720 be written off. This write off to be expensed to account 3364 ('Other Health' Operating Expenditure)."

#### 12.6 Budget Adoption – 2020/2021 Annual Budget

"That the 2020/2021 Annual Budget, as attached, be adopted."

#### 12.9 Vehicle Log Books and Cost of Private Use

It is one of the responsibilities of Council via the Audit and Risk Committee to review and recommend appropriate actions with regards to audit, risk and governance management to ensure accountability to the community in its responsibilities.

Council is currently considering the cost of private usage of Shire owned vehicles as part of this process.



# What's New in our Library?







# Early Years Activities

### Pom Pom Sorting:

Create a simple matching game to teach little ones about colour. Find a pack of readymade pom-poms in your local craft shop, or get an older sibling to help <u>make a pom-pom</u> using wool. Draw coloured circles onto a large sheet of paper, then help your toddler to sort the different pom-poms into the right colour groups.

## **Coloured Rice**

To make your own brightly coloured rice, put about a cup (185g) of any dried rice with your choice of gel food colouring in a container. Add ½ tsp vinegar to the rice – this stops the dye from transferring – then put the lid on and shake well to mix. Spread the rice out in a thin layer on a baking sheet to dry for 2-3 hours before using.

# Community survey dramatically improved understanding of Carnaby's cockatoo breeding areas in the SW region


Community members across the South West Catchments Council (SWCC) region have recently contributed more than 150 historical sightings of black cockatoos, including the endangered Carnaby's cockatoo, to an online survey aimed at understanding the habitat these birds are using across the region. Prior to this survey, there were only two registered breeding sites for the Carnaby's cockatoo within the agricultural areas of the SWCC region. Thanks to the efforts of the local community, a further nine breeding sites have been reported. Local Landcare groups will undertake detailed surveys of these nine sites in the breeding season, which is now underway. In addition to the nine breeding sites reported, a further 26 roosting sites and 91 feeding locations were also reported in the survey. Nineteen sightings of locations where cockatoos were drinking were also reported. Feeding and drinking sites are particularly important to understand as the availability of these sites are crucial for the birds to breed successfully.

Many landholders also contributed to the survey by reporting that they had not seen black cockatoos using their properties. This information is almost as important as knowing where the birds breed, roost and feed, as it ensures that efforts are not wasted trying to find birds in areas that they don't regularly use.



With Carnaby's cockatoos now having moved inland to breed this year, the survey effort will continue to gather information on the areas that the birds are currently using. Community members are encouraged to continue to contribute sightings to the survey which be accessed can at https://app.maptionnaire.com/en/7399/. Alternatively, sightings can be reported to your local Landcare group.

The information gathered through this ongoing survey will help to guide on-ground work to improve breeding outcomes, by ensuring that nesting sites have enough hollows for breeding birds as well as having adequate feeding and watering areas within the area surrounding these sites.

# Stop the GREEN CANCER now!

Golden Wattle (*Acacia pycantha*) it is one of several Australian wattles that are known as the "green cancer" for their invasive nature. The Shire of Kojonup's Natural Resource Management Advisory Committee and Friends of Myrtle Benn Group have been trying to raise awareness about this weed and encourages members of the public to remove the trees if they are on their property.

While there is no obligation under legislation to remove these trees, it is important to be aware of their invasive nature and quickly control any new seedlings that might appear on your property.



# GOLDEN WATTLE (Acacia pycantha)

The Golden Wattle is usually a shrub or small tree to 5m tall, but sometimes taller, often with white, powdery bark on branches near the crown. It grows in many soil types and has a shallow and spreading root system which prevents competition from other species. It has a very fast growth rate and produces masses of seeds which are 55-85% viable. (FloraBase)

#### **Environmental Impact**

Golden wattle is a 'moderately important' environmental weed in Western Australia and Tasmania. It is also regarded as an environmental weed in those parts of New South Wales that are outside its native range.

This species is one of the weediest eastern Australian wattles in Western Australia. In the south-western parts of the state, golden wattle is an abundant and increasing weed of roadsides and is also becoming invasive in nearby woodlands. Golden wattle is also an environmental weed in South Africa, where it competes with and replaces indigenous species (i.e. transforms native vegetation). Dense stands are known to burn fiercely, which provides a further hazard for the indigenous flora and fauna in this country. Under current Legislation, the golden wattle is not declared or considered noxious by any state or territory

government in Australia.

#### Management

Management practices depend on the size and density of the stand:

- Old large trees may be felled and the cut stump immediately painted with neat glyphosate or 1:60 Access<sup>®</sup> in diesel to prevent regrowth.
- In large dense stands a hot fire may be used to allow better access and encourage seed to germinate so that it may controlled by herbicides and reduce the soil seed bank.
- For mature or juvenile trees, apply a mixture of 1 L of Access<sup>®</sup> in 60 L of diesel to the lower 500 mm of the trunk or inject the stems with 1 mL Tordon<sup>®</sup> Timber Control herbicide per 1.5 metres of height. Autumn is probably the best time to apply and repeat in 6 months if necessary.
- For seedlings, apply 4 L/ha of glyphosate (450 g/L) or spray until just wet with a mixture of 100 mL of glyphosate (450 g/L) per 10 L of water in spring.
- For juvenile trees, spray a mixture of 100 mL of glyphosate (450 g/L) (or 25 mL Garlon480) plus 25 mL Pulse<sup>®</sup> Penetrant per 10 L of water onto the foliage until just wet in spring. A concentrated mix of 1-part glyphosate with 2-parts water can also be applied using a window washer bottle. Apply about 3 mL of this solution per square metre of foliage. Lontrel<sup>®</sup>750 at 2 kg/ha may provide more selective control in some situations.
- Avoid further burning or denuding the area as this will encourage seedling establishment.
- Repeat treatment every second year to ensure that no trees reach an age where they can set seed.
- Use glyphosate, Garlon<sup>®</sup>, Grazon<sup>®</sup> Access<sup>®</sup> or Tordon<sup>®</sup> Timber Control to paint the stumps immediately after felling or inject herbicide into the trunk as this species tends to coppice or sucker after being damaged.

## Only Flush the Three P's – Pee, Poo & Paper

Flushing the wrong thing down toilets can damage your home and our local wastewater system. Items like kitchen towel, cotton buds, wet wipes, nappies and plastic bags should not be flushed down the toilet as this material does not break down like toilet paper.

This month Water Corporation has removed two very large 'pipe monster' blockages from the Kojonup wastewater system and are now urging local residents to not take their wastewater services for granted.

It's up to all of us to take care of our wastewater system and avoid blockages, as they are not only costly to remove but can cause damage to plumbing and homes.
