11 STATUS REPORTS

11.1 REVEGETATING ALONG THE OLD RUBBISH TIP ROAD

Klopper Earthmoving were engaged in late May 21 to carry out levelling of dumped material along the roadside to allow for weed control and future restoration.

11.2 RESERVE MANAGEMENT PLANS

The Corporate Strategic Plan, reference 1.2.6 (page 12) states that Works and Services will develop environmental management plans for significant Shire Reserves, which should be completed in 2020/2021.

Progress has commenced with an audit of all reserves in the Shire of Kojonup. Reserves vested in the Shire of Kojonup are now being investigated more closely.

No further action at this time – will make priority during 2021-2022

Committee agree to focus on reserves that have already had treatments prior to commencing other reserves including the below:

- Orchid Valley and Qualeup Reserves continue weed management that has previously had treatment.
- Boscabel Reserve old town hall/tennis courts have weedy wattles which are being progressively removed by John Benn.

Action: Look at whole of shire reserves and connectivity and how these can be improved.

Previously South Coast NRM/ SWCC completed surveys of the reserves through the land for wildlife project – this is no longer funded.

Action: Adele to inspect reserves with Paul to look at the works undertaken to date and prepare a plan for future works and prioritisation.

11.3 GEOGRAPHICALLY STRATEGIC FOX BAITING INTERVENTIONS COLLABORATED ACROSS THE GREAT SOUTHERN DISTRICT AREA OF WA TO REDUCE POTENTIAL INJURY OR DEATH TO OUR INDUSTRY-VITAL FARM SHEEP POPULATIONS

Final reporting for this is almost complete and awaiting data from landholders to be submitted by EOFY.

Jen reported that baiting has been successful on her property however it does require some effort to place and retrieve.

11.4 TOWN WEED MAPPING

Council as per Decision 166/19 has endorsed making a provision of \$10,000 in the 20/21 Budget to commence the removal of Eastern States Wattles. It is intended that the 'Weedy Wattles' pamphlet will be delivered at the same time as the removal of trees within the townsite to help raise awareness of the weed.

Action: To be progressed by Adele and Marina.

11.5 PEST PLANTS LOCAL LAW

A draft agenda item has been prepared in regards to Committee Decision 24/18 whereby the Natural Resource Management Advisory Committee recommended to Council that a Local Law is developed to eradicate the following species from the Shire:

- 1. Pattersons Curse (Echium plantagineum);
- 2. Black Wattle (Acacia decurrens);
- 3. Golden Wattle (Acacia pycantha); and
- 4. Flinders Range Wattle (Acacia iteaphylla).

Action: Adele to research if there are any other councils in WA that have a local law associated with this and use as an example.

11.6 FRIENDS OF MYRTLE BENN UPDATE

A busy bee was conducted 2 June 2021 for Tagasaste removal, cut and wipe. A Contractor engaged to spray grasses/freesia and other weeds in Myrtle Benn Flora and Fauna Sanctuary and commenced spraying in the burnt area across the cemetery.

Proposed dates and locations for next busy bees to be determined, noting Adele will be away for School holidays in July and attending the National Landcare Conference in early August.

11.7 NATURAL RESOURCE MANAGEMENT (NRM) DROUGHT RESILIENCE PROGRAM – SUCCESSFUL

Adele reported that previous NRM/Landcare Officer applied for this program in October 2020 and was notified of our success in May 2021. The project includes two trial sites of 10ha with perennial pasture and saltbush. Adele has requested an extension as at the time of application the sites were not determined and this needs to be through an EOI process or through working with Southern Dirt's landholder group. Saltbush plants diversity/availability from nurseries is poor and to have the best impact project outcomes we should have best plan in place especially if we want landholders to uptake the practice.

Action: Adele to advise committee if extension granted for the project.

11.8 OLD RUBBISH TIP SITES - ERFF FUNDING APPLICATION - NEW

Adele is working on an application for restoration of two (2) sites over the two-year funding period which Includes green jobs training for seed collection and weed control:

- Site 1 Robinson Road is 3ha
- Site 2 Landfill area on Albany highway is 5 ha.

Amalgamation of Myrtle Benn and surrounding lots (old tip site) is underway as part of the changes to the Town Planning Scheme and consolidation of Reserves.

11.9 STATE NRM FUNDING 2021-2024 - NEW

Application for a large grant covering three properties was submitted which includes fencing and revegetation of salt affected areas and creek lines to Simpson, Leach and Coleman properties west of Kojonup. Total project \$448,280 with Grant funding of \$179,266 plus contribution from landholders. Notification due in November 2021

11.10 SHARP RUSH SURVEY

Results are on the system and need to be processed, reviewed and communicated to the community, including future monitoring/programming.

11.11 CORPORATE BUSINESS PLAN -ACTIONS RELATING TO NRM

Marina noted we have commenced looking at Reserve Management Plans however do we have idea on meeting these actions?

- 1.2.16 Friends of Myrtle Benn Committee– Encourage more members
- 1.2.17 Friends of Myrtle Benn Committee Weed control through the walk trail area seek funding for woody weed control
- 1.2.18 Friends of Myrtle Benn Committee fire management to protect habitat trees

11.12 FUTURE FUNDING/WORKSHOPS

- Committee members proposed that in sourcing future grant opportunities we look at options that are more community related rather than with a focus on individual landholders.
- Workshop on managing bushland adjacent to or on property especially for weed/fire management be considered.
