Great Southern Climate Alliance Update – Shire of Kent, Woodanilling, Katanning, Broomehill-Tambellup, Jerramungup, Gnowangerup, Katanning and Kojonup have come together as the Great Southern Climate Alliance.

Myrtle Benn Reserve – risk assessment for bushland, Shire of Kojonup has many assets, deemed extreme risk identified in the Bushfire Risk Mitigation Plan. The Shire of Kojonup is an overall extreme risk from a bushfire perspective. Mitigation has not been undertaken within the Shire over multiple years.

Fuel load and no mitigation could mean a hot, out of control burn putting the town at risk. Council confirmed the need to act on mitigation.

Discussed with DFES and came up with a plan to mitigate the risk. Local fire brigades were involved in the decisions and mitigation. Discussed with Wagyl Kaip.

Discussion has been had to try to stop vehicles from going in there, put gates in place and only allowing walking tracks is the best control. Needs further discussion.

A suggestion to support Clean Up Australia Day, place information in the Koji News.

Invite Southern Dirt to have a meeting with the Committee to collaborate ideas and assist the NRM Committee.

Invite Shane Harris to the next meeting, to discuss the ongoing works at Myrtle Benn Reserve and any future works to be done at Farrar Reserve and at the Show Grounds.
