9:00am – 9:55am	Sergeant Phil Cartledge – Kojonup Police to meet with Council and to discuss community expectations, etc.	<p>The Shire President on behalf of Council welcomed Sgt. Cartledge to Kojonup who has recently commenced a 2 year stint with Kojonup. Sgt. Cartledge indicated that acting Sgt. Dave Murphy from Albany, JD, Peter and Kristy had a busy few weeks before his arrival and he was looking forward to the challenges and opportunities. Being a member of WA Police for 21 years and Officer in Charge at 4 country towns he is familiar with the challenges that Kojonup presently faces especially the dramatic increase in burglaries and theft. A series of raids has recently been undertaken and additional police resources allocated in an effort to apprehend offenders.</p> <p>Community members are becoming more vigilant in their efforts to secure property, notice unusual movements by people and vehicles and above all to report same to Crime Stoppers or Police. The introduction of Neighbourhood and Rural Watch reinforces the message that the bulk of the community is taking measures to protect each other and has had enough of this crime wave.</p> <p>Police have various offenders that they will continue to target including increased vehicle stops at all hours in an effort to disrupt and seize stolen</p>

		<p>goods and contraband as well as undertake RBT. Sgt Cartledge indicated that he is the first point of call for Kojonup whenever contacted by Albany and is keen to ensure communication channels are two way. He is removing the office closed sign as the office should always be accessible regardless of time plus it provides offenders notice of when police are on duty.</p> <p>Sgt Cartledge did state that it takes approximately 20 minutes for officers to be fully kitted when not on duty hence the reason in some instances for longer than anticipated response times. Businesses, etc. are installing security cameras and he would support Council's application for increased CCTV coverage in Kojonup which would be monitored by Police.</p> <p>Sgt Cartledge looked forward to playing a few rounds of golf during his days off and meeting as many community members as possible.</p>

11:10am – 11:50am 12.15pm – 12.45pm 1.20pm – 1.45pm	CEO – VROC Strategic Directions Workshop	<p>The CEO, MCS, MRS and DSC spoke on their respective involvement with Resource Sharing and other projects undertaken at a VROC Level. CLGF funding has greatly assisted the VROC to "get runs on the board" however, there was a protracted time frame undertaking the kerb-side, etc. Waste Management Tender with the MCS and MRS leading the process in the absence of required comparative information and data.</p> <p>The true costs for this work has not been captured or directly attributed to VROC which raises the question – what level of resourcing is required to undertake agreed projects? Broomehill-Tambellup have undertaken the task of acquitting all grant funds allocated to the various projects which is greatly appreciated by Kojonup, however the full merits of Resource Sharing, process/system reviews, etc. will not progress unless council's genuinely commit!</p> <p>The Strategic Directions have not been progressed as quickly as anticipated and unless PD's for officers stipulate the need to participate in VROC there is no legal requirement for officers to make exceptions. The existing model also places emphasis on CEO's and the part-time Executive Officer to undertake the majority of tasks (due to staffing levels of smaller Councils?) and there is always the possibility that not all Council's will opt in which is fine as the</p>

		<p>project outcomes/costs/benefits should make this determination! For example: sharing IT, Payroll, Rates, HR functions, etc. should be explored and if not feasible within the VROC look at extending opportunities or sourcing resources to/from neighbouring Council's such as the City of Albany. With the change in Elected members and Management at Katanning is there a corresponding change in receptiveness to also including Katanning in forward planning?</p> <p>How much ownership and understanding do existing elected members have of their respective council's involvement with VROC?</p> <p>VROC is a valuable resource to Kojonup but collective aims and objectives need to be clearly translated into realistic projects which are appropriately measured, supported and implemented.</p> <p>The next Full VROC meeting is being held on Wednesday, 10 August 2016 at Cranbrook commencing 3:00pm.</p>
