1:00pm - 1:30pm	Manager of Regulatory & Community Services to give an update on the: • Waste Water Reuse Project after meeting with Water Corporation on Thursday 26 February 2015.	Met with a contingent from Water Corporation, headed up by Nadelle Brooks (Water Corporation). Jessica van der Waag from the Katanning office of GSDC (Great Southern Development Commission) also attended the meeting where discussions were had on the possibility of Kojonup being identified for waste water harvesting. Very positive meeting where Kojonup presented themselves well and encouraged the Water Corporation that we're worth backing. There will be a workshop with Officers held later this month (26th March) to discuss things further. Shire will be able to partner in with Education Department. CEO has contacted the Principal of Kojonup District High School, Mr Peter Callaghan, who has expressed a keen interest to become involved in the project (stage 2). The Waste Water Scheme could well be one of the best in WA. Project has been split into 2 stages: Stage 1 has commenced and Stage 2 is dependent on sourcing grant funding. Water Corporation members were given a tour around town where there was discussion on the potential benefits at the South dam as a non-

		potable supply of water. Water can also be used for standpipes which will create a faster flow and cheaper rate. Overall outcome of meeting was very positive. Maximise availability, minimise cost. Update will be given at the Briefing Session after the workshop on how we move forward from here.
