Round One of the National Stronger Regions Fund now open The National Stronger Regions Fund (NSRF) is an Australian Government initiative to boost social and economic development in Australia's regions by funding priority infrastructure projects in local communities. The Australian Government has committed \$1 billion to the fund over five years commencing from 2015–2016. Funding will be provided for capital projects which involve construction of new infrastructure, or the upgrade, extension or enhancement of existing infrastructure. Projects selected for funding should deliver an economic benefit to the region beyond the period of construction, and should support disadvantaged regions or areas of disadvantage within a region. To best deliver critical infrastructure, the Fund encourages the formation of strong partnerships that engage project proponents with the private sector, and local, state and territory governments. Local Government and incorporated not-for-profit organisations are eligible to apply for grants of between \$20,000 and \$10 million. Grant funding must be matched in cash on at least a dollar for dollar basis, and the funded part of the project must be completed on or before 31 December 2019.

Applicants are strongly encouraged to read the NSRF Guidelines in conjunction with the Frequently Asked Questions and the Guide to Lodging an Online Application Form, which are all available on the Department of Infrastructure and Regional Development website at http://www.infrastructure.gov.au/nsrf

Applications for Round One funding will be accepted between 1 October 2014 and 5pm applicant's local time on 28 November 2014, using the Department's secure Grants Management System (GMS) Portal. Access to the GMS Portal will be available shortly on the Department's website http://www.infrastructure.gov.au/nsrf

Role of RDA Great Southern

Council identified the following projects that may meet the eligibility criteria:-

- 1. Sewer Pipeline extensions, Underground power and Stormwater Drainage/Footpath improvements for Loton Close and Katanning Road/John/Murby Street areas enabling approximately 65 residential blocks to be made available for development approximate cost \$825k N.B Water Corporation have ongoing issues with Sewerage Treatment Plant with storm water and solids infiltration;
- 2. Aged/Health/Medical Precinct work with Southern Inland Health Initiative to build a new Medical Centre, Consulting Rooms and Aged Care accommodation linking Kojonup Hospital with Springhaven Aged Care Facility. This approach would negate duplication of kitchen, laundry, car parking, staff, IT, back up emergency generator, energy efficiency approximate cost \$2m (Council has \$500k private bequest and budget allocation of \$300k);
- 3. Main Street Master Plan Staged implementation approximate cost \$2m (Council allocated \$100k this financial year) Includes Paving,

- kerbing, footpaths, cycle ways, Trails, signage, rubbish bins, seating, street trees, road works, underground infrastructure, energy efficiency, playgrounds, etc;
- 4. Sports Precinct Master Plan Staged implementation approximate cost \$1.6m including Creche, Gymnasium, Indoor Court, synthetic Hockey/Netball surface, Parking, energy efficiency etc;
- 5. Communications upgrade for Emergency Services (including new replacement tower), Wifi, Council Chambers, Kodja Place, Depot, Medical Precinct;
- 6. Water Reuse / Harvesting including hydrological assessment, improved storm water drainage/catchment/retarding basins at various locations including Showground Dams, Quin Quin Reserve, Apex Park, Springs, Pensioner Road & Loton Close, Farrar etc;
- 7. Kodja Place Precinct upgrades to multimedia, drainage, internal layout, café extension, street furniture, signage, storm water, car parking, etc. (GSDC involvement/Tourism Planning);
- 8. Pensioner Road/Town Streets reconstruction; and
- 9. Helicopter refueling mobile station for Kojonup Aerodrome and seal existing runway.
