COUNCIL BRIEFS

20 AUGUST 2019 COUNCIL MEETING OUTCOMES

Community Seminar – Drug Addiction

Endorsed the Shire President's actions for Mr. Peter Lyndon-James, Founder and Chief Executive Officer of drug rehabilitation centre, Shalom House to conduct a community seminar addressing "drug addiction" at the Sports Complex on Tuesday, 17 September 2019 commencing at 6.00pm.

Review of Council Policy 2.3.9 – Closed Circuit Television (CCTV) Operations and Recording

Council adopted the updated content of Council Policy 2.3.9 – Existing Closed Circuit (CCTV) Operations and Recording such that it clarifies areas of responsibility and accountability for all staff involved with the operational aspects of the policy, for their respective areas, in relation to CCTV.

2017/2018 Audit Report – Operating Surplus Ratio

1. The information contained within this report relating to the Operating Surplus Ratio be received;
2. It is recognised that the Operating Surplus Ratio may decrease further in 2018/2019 and 2019/2020 before improvements are experienced;
3. The Operating Surplus Ratio be reviewed by the Audit & Risk Committee at each meeting until such time as the 'Basic Achievement' standard is met; and
4. The Manager Corporate & Community Services be requested to forward a copy of the Committee and the Council agenda items to the Minister for Local Government and placed on the Shire website in accordance with Section 7.12A (Duties of local government with respect to audits) of the *Local Government Act 1995*.

Insurance Policies 2019/2020

Council noted that the insurance levels and associated costs held by the shire increased from \$354,933 to \$364,527 for the 2019/20 financial year.

Insurance is the most important risk management task undertaken each year. Insurance is our single largest ongoing external cost, and without adequate cover the Shire is extremely exposed to financial and property loss and open to liability.

Without sufficient insurance cover we run the risk of being unable to maintain our current level of service in the event of a major/catastrophic loss and possibly expose ourselves to litigation costs if not adequately insured.

The largest increase in premium related to LGIS Bushfire cover which is essential to ensure our Volunteer Bushfire members are protected when attending fires should an unfortunate event occur.

Proposed Extensions to Blacksmith's Shop Attraction at Kojonup Showgrounds

1. Council grant development approval for the extensions to the blacksmith's shop on the Kojonup Showgrounds at Lot 37 Blackwood Road, Kojonup subject to the following conditions:
 - a. The development to be in generally in accordance with the stamped approved plans, unless a variation has been approved by the Chief Executive Officer.
 - b. The improvements to be removed from the site when no longer required.
2. The Kojonup Pastoral & Agricultural Society be advised that as the Shire is required to incur additional costs of engaging an external Building Surveyor Contractor for the Building Permit process the request for donation of the application fee of \$147 be denied.

Main Roads WA Albany Highway Road Widenings – South of Kojonup

Council passed a resolution for the dedication of the land subject of Main Roads Land Dealing Plans 201901-066, 201801-0015, 201801-0016 and 201801-017 as a road pursuant to section 56 of the Land Administration Act 1997.

Elected Member Charter

Endorsed the updated Elected Members Charter, previously known as the Councillor Induction Manual, given the 2019 Local Government Elections and the introduction of the amendments to the *Local Government Act 1995* offered the ideal opportunity to review and update the previous manual.

Marribank Aboriginal Corporation – Request to Waive Rates

1. The Council is unable to waive its property rate account for the Marribank Mission in the 2019/2020 financial year of \$4,200;
2. Council make a donation to the Marribank Aboriginal Corporation of \$2100 for the 2019/20 Financial Year to assist with associated commencement costs, with such funds being allocated from account 1912, Councillor Conference Fees; and
3. Council will give consideration to further donations during the 2020/2021 and 2021/2022 budgeting process.

Request for Tender 01/2019/20 – Key Worker Housing – Design and Construct, PL8 Soldier Road, Kojonup Request for Tender 02/2019/20 – Key Worker Housing – Design and Construct, 13 Loton Close, Kojonup

Council issued tenders in accordance with evaluation criteria to:

1. The tender offer from Home Group WA Great Southern for a total of \$475,200 (including GST) for the design and construction of a new dwelling at PL8 Soldier Road, Kojonup in accordance with Shire of Kojonup tender specification 01/2019/20 subject to the floor and site plan being approved by the Department of Communities ; and
2. The tender offer from Wauters Enterprises Pty Ltd for a total of \$494,769.64 (including GST) for the design and construction of a new dwelling at 13 Loton Close, Kojonup in accordance with Shire of Kojonup tender specification 02/2019/20 subject to the floor and site plan being approved by the Department of Communities.

2019 LOCAL GOVERNMENT ELECTIONS - ENROL TO VOTE – ELIGIBILITY



In order to nominate, a person must be registered as a voter for the district in which they are standing as a candidate.

For Residents: The Commission maintains the residents roll. Individuals can confirm their enrolment status at the Commission's website www.elections.wa.gov.au

Non-Resident Owners and Occupiers: If you are a non-resident owner or occupier of rateable property in your Local Government area and are on the State or Commonwealth Electoral Roll, you are eligible to enrol to vote and should make an enrolment application to the Local Government. If you are not on the State or Commonwealth Electoral Roll and own or occupy rateable property in a particular Local Government, you may be eligible to enrol to vote if you were on the Local Government's last electoral roll prior to May 1996. Please contact the particular Local Government for details. Owners of land who were on the last roll of the Local Government continue to retain that status until they cease to own the rateable property to which the enrolment relates.

Occupiers do not have continuous enrolment and should contact their particular Local Government to confirm their enrolment status. To be eligible to enrol as an occupier, you will need to have a right of continuous occupation under a lease, tenancy agreement or other legal instrument for at least the next 3 months following the date of the application to enrol.

Joint Owners and Occupiers: If a rateable property is owned or occupied by more than two people, a majority of the owners/occupiers may nominate two persons from amongst themselves who are on either the State or Commonwealth Electoral Roll, to enrol as owner/occupier electors.

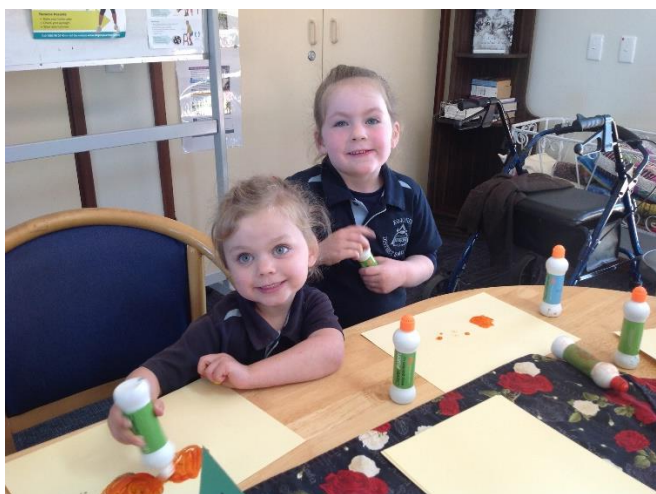
Corporations: A body corporate that owns or occupies rateable property may nominate two people who are on either the State or Commonwealth Electoral Roll to enrol as owner/occupier electors.

Enrolment Forms: Enrolment claim forms can be obtained from Local Governments or Australian Electoral Commission offices and should be lodged with the particular Chief Executive Officer by 5.00pm Friday 30 August 2019. If you registered for the 2017 elections or since that time you do not need to register.

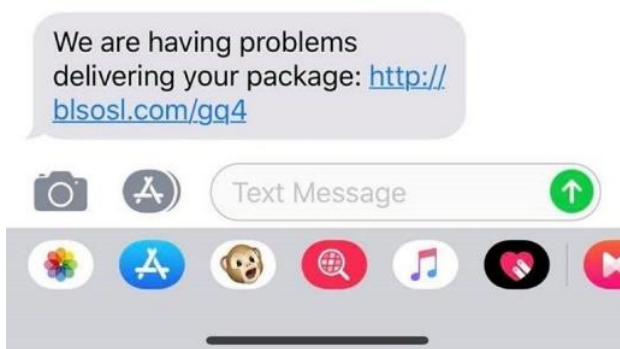

We wish to congratulate all those involved and hoped the sky was clear for you all to enjoy our wonderful night sky.

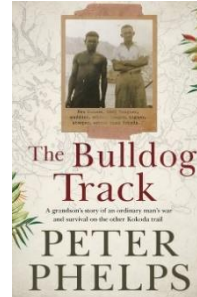
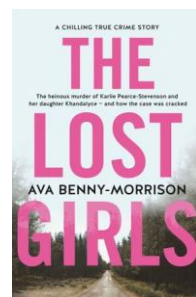
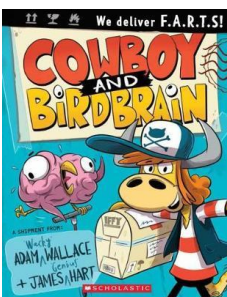
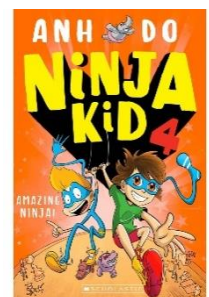
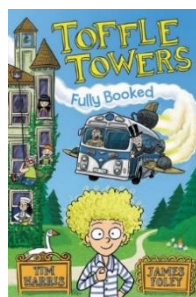
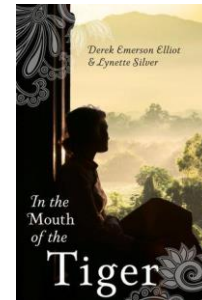
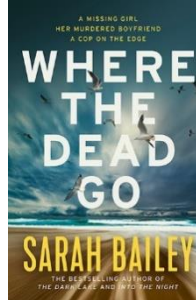
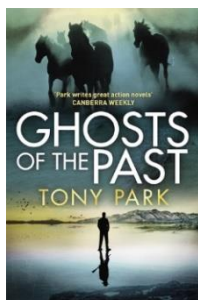
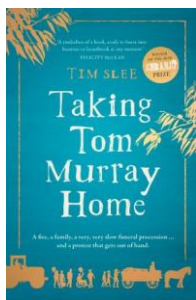

New to our Library- Come in & Check them Out!

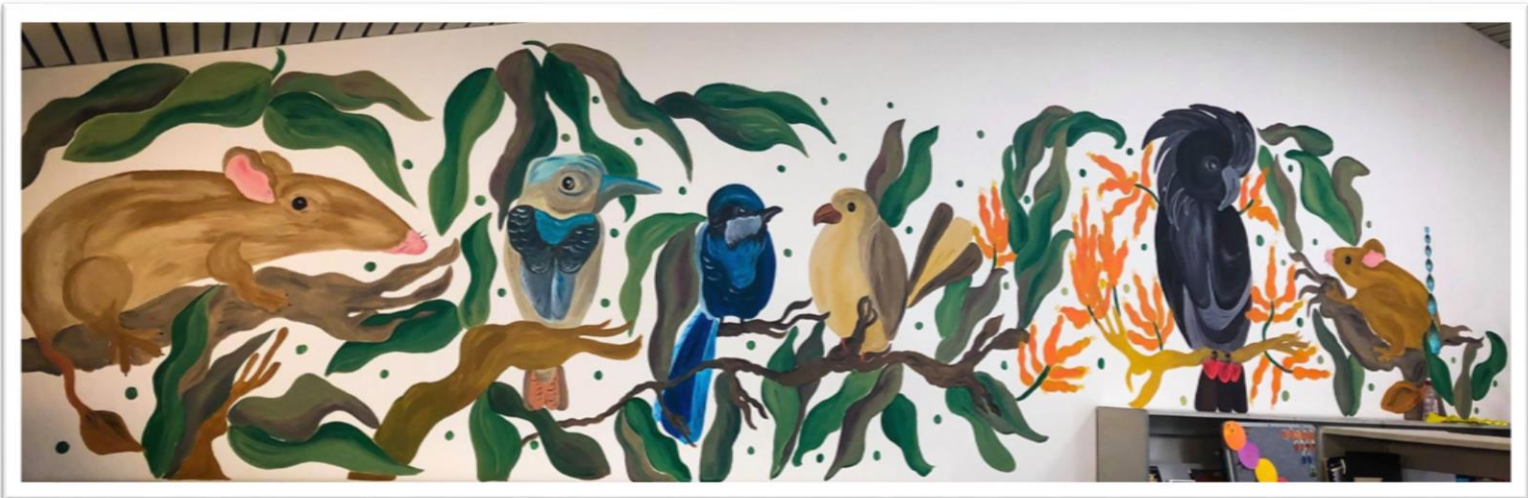


Kojonup Library Mural

DANGEROUS STORMS ARE THE MOST COMMON NATURAL HAZARD IN AUSTRALIA.



Every year from May to October, storms including tornados, lightning, hail, flash flooding and gale force winds cause major destruction to the southern half of WA. As storms are unpredictable and generally impact a small area, their devastating impact is often underestimated.

Storms not only cause damage to homes, property and businesses, they also pose a threat to people, animals and the environment.

Here are a few things you can do to prepare your home and families for storms:

- Trim branches around your home to prevent them falling on your roof or car.
- Clear gutters and downpipes so they do not overflow after heavy rain.
- Store or weigh down loose objects around your home or work, such as outdoor furniture that could be picked up and thrown by strong winds, causing damage or injury.
- Prepare an emergency kit with a battery operated radio, torch, spare batteries and first aid kit.
- Have an emergency plan ready to put into action, including a relocation plan for your family and pets in case your home becomes flooded.

Remember, if a storm has badly damaged your home and you can't safely fix it yourself, SES are there to help. If you need assistance call 132 500.

Kojonup Spring

The first official exploration was done by surveyor Alfred Hillman who had been assigned the task of marking a track from King George Sound (Albany) to Perth in 1837. Unable to find water, Hillman was guided to the 'Spring' by the local Noongar people in the summer heat of February 1837. Hillman recommended to Governor Stirling that the 'Spring' was a good place for an outpost.

drumMUSTER Factsheet

Program Information

drumMUSTER is the national program for the collection and recycling of eligible non-returnable crop production and animal health product chemical containers from manufacturers participating in the Industry Waste Reduction Scheme (IWRS).

What does *drumMUSTER* mean for Australian rural chemical users?

drumMUSTER provides the best solution to the problem of disposing of empty chemical containers. It is cleaner, safer and more cost effective than other disposal methods.

Why use the *drumMUSTER* program?

drumMUSTER is the only responsible way for disposal of farm chemical containers. By using the program chemical users are:

- limiting farm risk
- limiting environmental risk

What are the benefits of using the *drumMUSTER* program?

- *drumMUSTER* meets the requirements of Quality Assurance programs and Environmental Management Systems. Chemical users are provided with a receipt for all drums delivered to the program.
- Continues to ensure Australian food safety standards are maintained.
- *drumMUSTER* is an effective way of recycling farm waste.

Which containers are accepted at a *drumMUSTER* collection?

Chemical containers on which the levy has been charged will have the *drumMUSTER* eligible container logo attached (see above).

The label can be placed on the container as a sticker, included on the product label or embossed onto the container.



If the container does not have a logo it may be because the manufacturer has opted out of the program and therefore no levy is being charged, or because the container does not fall under the *drumMUSTER* eligibility criteria (these will not be eligible for collection.)

Which containers will not be accepted at a *drumMUSTER* collection?

Containers will not be accepted if they:

- have not been properly cleaned and drained inside and out (including the threads and caps) and have visible chemical residue,
- are not eligible for *drumMUSTER* collection.

Levy

Chemical users pay a six cent (6) per litre or kilogram levy when they purchase eligible products displaying the above logo.

No Logo-No Go

Program Eligibility

Eligible containers must carry the *drumMUSTER* logo. It will appear either:

1. on the label,
2. applied as a sticker to the container or label, or
3. embossed onto the wall of the container.
