10. STATUS REPORTS

10.1 Emergency Services Levy Update

ACTION: Matter deferred in the absence of Mr Cowie as CEO did not have any briefing notes for the meeting.

10.2 Fire Signs

CEO outlined the Townscape Committee's decision to move towards two digital signs that would be erected prior to the next bushfire season once 2019/20 budget adopted in July 2019. These signs will be able to be utilised to advertise other local content throughout the year.

It was suggested that the Firebreak Notice be handed out with the Rotary Calendar and also the dates be printed on the calendar. CEO advised that restricted etc., dates were also being included in "Resident Information" packs and on social media.

ACTION: CEO to ensure Rob Cowie investigates and liaises with Rotary Club of Kojonup, noting that Kojonup Lions Club also undertake a similar initiative.

10.3 Bushfire Maps

The current Fire Maps were last updated in 2008. These need to be updated, but this is quite a large project and will take some time to complete. This will require a collective approach with assistance from Brigades, FCO's and Zulus to ensure all farm names are correct.

Committee agreed that the Fire Map needed to be updated and that the Brigades could be helpful in making certain that all properties are captured and correct.

Roger House suggested that the new maps be available in a digital format.

ACTION: CEO to ensure this matter is progressed including budget provision.

10.4 Signs at Fires

The shire will purchase signs to be located on the Kojonup and Muradup 2.4 Trucks possibly through ESL?

11.1.1 Election of CBFCO, DCBFCO and two (2) Senior FCO's

Following the Kojonup Volunteer Bushfire Association (KVBA) AGM held on Wednesday 3 April 2019, it was recommended to the Kojonup Bushfire Advisory Committee that:

- "a) Tony Fisher be recommended for the Chief Bushfire Control Officer for the 2019/2020 year.
- b) Roger House be recommended for the Deputy Chief Bushfire Control Officer for the 2019/2020 year.
- c) Ross Fryer-Smith and Myles Reid be recommended for the Senior Bushfire Control Officers for the 2019/2020 year.
- d) The CBCO and the DCBCO are recommended for the Fire Weather Officer and Deputy Fire Weather Officer respectively for the 2019/2020 year.
- e) The CBCO and the DCBCO are recommended to be appointed as authorised officers to issue permits to burn for the collection of clover seed in the Shire for the 2019/2020 year.
- f) The CBCO, DCBCO and the two Senior FCO's be authorised to advise the CEO of the Shire of Kojonup on the imposition of Harvest and Vehicle Movement Bans for the 2019/2020 year."

11.1.3 Communications Tower

Letter from Qualeup Brigade was tabled at the AGM urging Council proceed with the February 2017 motion of building a standalone tower.

AGM moved the following motion:

"The Kojonup Bushfire Association wish to record a motion of censure of the Kojonup Shire Council in not progressing the installation of an adequate communication system for the use of the Fire Brigades in carrying out their duties as fire fighters."

Mr Binns spoke to the above motion. CEO advised that improved communications is vital not just for the present but also the future (10 + years). Stating one council decision in isolation to the other motions elected members had passed since February 2017 did not highlight that Cr Sexton (prior to his retirement in October 2017) and Cr Radford identified 2 other possible locations that Council via its officers was asked to compare against the existing tower site given concerns previously expressed regarding:

- Access to the tower for maintenance,
- Lack of a previous written Memorandum of Understanding or Agreement with landowner which Council now possesses,
- No permanent access to Western power supply as presently using solar and battery,
- On-going service agreement with tower and equipment placed on same,
- Structural integrity of existing tower,
- Replacement of missing 5 metres of mast,
- Licence requirements and retention of existing comms channels if an alternative site chosen,
- Audit of brigade/volunteer/council/other potential user radios to establish age, condition,
- Past relationship with DFES and why WAERN was located on the Police Tower.

The meeting on 17 April 2019 with DFES is a step forward in the right direction to achieve the following:

- 1. A commitment to test and use the VHF High Band (WAERN) radio platform for communications between the shire, CBFCO, Zulus and FCOs for fire ground operations. The UHF CB platform is still anticipated to be the primary platform for use to direct operations with ground crews.
- 2. Identification to suitable sites (including greenfield) to enable DFES Communications to develop Radio Shadow Maps to provide the best information to guide future decisions.
- 3. An agreed process and timeframe to enable an acceptable solution to be identified and implemented.

Committee Members look forward to attending next week's meeting with DFES.

11.1.4 All in one weather stations

Roger House stated that 'All in one weather stations' are a nice to have but ultimately property owners know conditions that may result in recommending a harvest ban within the shire which may include Kestrel readings as part of radio scheds.

11.1.5 Ryansbrook Fire

The AGM supported the following motion 14/4:

"That the Heggaton family of Evergreen Grazing Company not be granted burning permits during the restricted burning period and that their open burning season end on the 15 August. The ban to be reviewed after a period of three (3) years."

Considerable discussion followed with Zulu 1 advising that the property owner has already been advised that fire permits will not be issued for the remainder of this fire season and a continuation of restrictions that were placed on restricted burning last year.

Zulu's should not be the judge, jury and executioner hence the final decision on the above motion rested with the Shire of Kojonup.

Tony Fisher advised that weather conditions will determine any extension to the present 15 April 2019 restricted burning period.

11.3 Reserve Firebreaks

Shire of Kojonup – Bushfire Advisory Committee Meeting – Minutes – 10 April 2018

Paul Retallack reported that a Dozer has been organised via DFES to improve fire breaks commencing at least 20 metres from Blackwood Road and more internal breaks to allow mosaic fire control burns at the Muradup Reserve and push up heaps. Bob Francis stated the reserve would be a good training exercise for brigades around June/July when the heaps are burnt.

Paul indicated a similar controlled burn is required in the reserve at the Katanning Road Standpipe and also in the SE corner near Myrtle Benn. All subject to appropriate weather conditions.
